Entry fees: MEDA-members: **\$15** first test, **\$10** each additional test (*same horse/rider combo*)

Non-MEDA members: **\$5 addtl/class** - can join at show/clinic and receive discount.

Stabling/Warm-up at VI: Stalls available at VI: **\$20/night, bedding provided, muck before departure.** Warm-up ring will be available throughout the clinic and show. *Please note: all participants and observers must be off VI premises by 8:00 pm each evening in compliance with college regulations.*
